#### Approval of Minutes for the June 23, 2021 CHRB Meeting:



### Virginia Retirement System (VRS) Financial Reports

CHRB Administrator Anne Pace discussed several documents with the members to include the following: [Source of documents: VRS Finance Division]

- 1. VRS Investments Report for the quarter ending June 30, 2021
  - The VRS Trust Fund achieved a record-setting return of 27.5% exceeding the total fund benchmark and far surpassing the 6.75% annual assumed rate of return.
  - The fund ended the year with approximately \$101.8 billion, crossing the \$100 billion mark for the first time in its history.
- 2. Analysis of Commonwealth Health Research Fund Activity Report reflects the June 30, 2021 CHRF ending balance at \$48,389,925.
- 3. Performance Summary Rolling Periods ending June 30, 2021 which reflects Total VRS Fund Performance for various periods ranging from 1 year to 10 years.

## CLOSED SESSION: FY 2022/2023 CHRB Grant Process

#### **MOTION**

Dr. Lowe moved that the Board go into closed session in accordance with the provisions of Sections 2.2-3711(A)(7), 2.2-3711(A)(30), and 2.2-3705.6(17) of the Code of Virginia, for the purpose of

Consultation with legal counsel and briefings by staff members or consultants pertaining to actual or probable litigation, where such consultation or briefing in open meeting would adversely affect the negotiating or litigating posture of the Board, and consultation with legal counsel employed or retained by the Board regarding specific legal matters requiring the provision of legal advice by such counsel regarding:

records submitted as a grant or loan application, or accompanying a grant or loan application.....to the extent such records contain proprietary business or research-related information produced or collected by the applicant in the conduct of or as a result of study or research on medical, rehabilitative, scientific, technical, technological, or scholarly issues, when such information has not been publicly released, published, copyrighted, or patented, if the disclosure of such information would be harmful to the competitive position of the applicant. Virginia Code § 2.2-3705.6 (17).

Dr. Eppes seconded the motion; which was voted upon and approved unanimously.

Dr. Lowe moved that the Board reconvene in open session. Julia Spicer seconded the motion. The motion was voted upon and passed unanimously. The Board adopted the following resolution by roll call vote.

**<u>CERTIFICATION</u>** (After closed meeting; roll call vote)

Dr. Lowe moved, and Ms. Spicer seconded, the adoption of the following resolution:

**WHEREAS**, the Commonwealth Health Research Board has convened a closed meeting on this date pursuant to an affirmative recorded vote and in accordance with the provisions of The Virginia Freedom of Information Act; and

**WHEREAS**, Section 2.2-3712 of the Code of Virginia requires a certification by this Board that such closed meeting was conducted in conformity with Virginia law;

**NOW, THEREFORE, BE IT RESOLVED,** that the Commonwealth Health Research Board certifies that, to the best of each member's knowledge, (i) only public business matters lawfully exempted from open meeting requirements by Virginia law were discussed in the closed meeting to which this certification resolution applies, and (ii) only such public business matters as were identified in the motion convening the closed meeting were heard, discussed or considered by the Board.

A roll call vote of members present approved this resolution unanimously.



CHRB Member Julia Spicer made a motion that 24 Concept Papers be developed into Full Proposals. Dr. Lowe seconded the motion. The motion was voted upon and passed unanimously. Administrator Pace will contact these 24 Principal Investigators regarding the CHRB's request for a Full Proposal submission. Administrator Pace will also provide reviewer comments to those Principal Investigators from whom Full Proposal submissions will not be requested.

## Other Business to come before the Board:

## Election of CHRB Officers effective November 1, 2021:

The Board unanimously approved the election of CHRB officers for November 1, 2021 through November 1, 2022: Robert Downs, Jr., M.D. was re-elected as CHRB Chair and Eric Lowe, M.D. was re-elected as the CHRB's Vice Chair.

#### Annual Financial Disclosure Forms due by February 1, 2022:

The Virginia Conflict of Interest and Ethics Advisory Council has issued a reminder regarding the requirement that each of the CHRB's members submit an annual financial disclosure form. All disclosures must be submitted electronically through the on-line filing system. Administrator Pace will coordinate this process with the members.

State Council of Higher Education in Virginia (SCHEV) Commonwealth of Virginia Engineering and Science (COVES) Fellowship Report on Basic Research Funding in Virginia:

This report was completed by Nikita Lad; a Ph.D. candidate at the Department of Environmental Science and Policy at George Mason University. As part of her research, Ms. Lad interviewed 31 stakeholders across Virginia to include the Commonwealth Health Research Board Chair, Dr. Robert Downs, Jr., and Administrator, Anne Pace.

From these interviews, Ms. Lad provided that, "there is a need for Basic Research (BR) support in the Commonwealth as it has heavily focused on commercialization and economic development in the past. Other recommendations:

- The state needs to define its role in BR and pick leaders in an area of research: recognize the strengths of each university by having a repository, enhance, and advertise/communicate them.
- The state should look for more public-private and/or national labs partnerships and invest in keyresearch infrastructure & equipment (like the Higher Education Equipment Trust Fund-HEETF) and ensure equitable but differentiated regional distribution.



- SCHEV should act as a conduit/liaison/advisory/oversight entity that has an objective voice to ensure coordination and no duplication within universities BR activities.
- More investments are required for hiring eminent scholars, faculty, operational support, graduate students by evaluating current mechanisms, and providing seed grants or matching dollars for federal resources.
- BR is not restricted to higher education; it does involve non-profits/profit institutions as BR is the pipeline to commercialization/translational research, and
- The state should not expect immediate returns on investment.

## **Next Meeting:**

Dr. Downs moved that the meeting be adjourned. The motion was seconded by Dr. Lowe, voted upon, and passed unanimously by the Board. The meeting adjourned at 1:31 p.m.

The Board's next meeting will be Thursday, March 31, 2022 in Richmond, Virginia at the Jepson Alumni Center, Rosenbaum Conference Room, University of Richmond. The meeting will begin promptly at 10:00 a.m. At this meeting, as part of the 2022/2023 grant review process, the Board will review the recommendations of the review panel and determine which Full Proposals should be presented to the Board.
