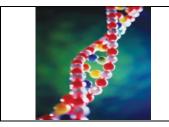
Vice Chair Eric Lowe, M.D., moved that the Board go into closed session pursuant to Virginia Code § 2.2-3711 (A) (7), § 2.2-3711 (A) (30), and § 2.2-3705.6(17) for the purpose of

Consultation with legal counsel and briefings by staff members or consultants pertaining to actual or probable litigation, where such consultation or briefing in open meeting would adversely affect the negotiating or litigating posture of the Board, and consultation with legal counsel employed or retained by the Board regarding specific legal matters requiring the provision of legal advice by such counsel regarding:

records submitted as a grant or loan application, or accompanying a grant or loan application.....to the extent such records contain proprietary business or research-related information produced or collected by the applicant in the conduct of or as a result of study or research on medical, rehabilitative, scientific, technical, technological, or scholarly issues, when such information has not been publicly released, published, copyrighted, or patented, if the disclosure of such information would be harmful to the competitive position of the applicant. Virginia Code § 2.2-3705.6 (17).

Vice Chair, Eric Lowe, M.D., made a motion to approve the FY 2024/2025 grant related documents effective July 1, 2023. Julia Spicer second the motion. This motion was unanimously approved.



CLOSED SESSION: Personnel and Budget Discussion

In accordance with the provisions of Sections 2.2-3711 (A)(8) and 2.2-3711 (A)(1) of the Code of Virginia, Vice Chair, Eric Lowe, M.D., moved that the Board go into closed meeting for the purpose of

Consultation with legal counsel employed or retained by the Board regarding specific legal matters requiring the provision of legal advice by such counsel regarding a personnel matter pursuant to Virginia Code § 2.2-3711(A)(1); more specifically: the administrative budget and terms, conditions, and salary of each of the scientific consultants' and the Administrator's contracts.

The motion was seconded by Julia Spicer. The motion was voted upon and passed unanimously.

Merrill Mitler, Ph.D., M.P.H., Raya Mandler, Ph.D., and Arnold Revzin, Ph.D. were not present during the personnel and budget discussion.

Julia Spicer moved that the Board approve the CHRB Administrative Budget for FY 2023/2024 in the amount of \$550,723.78 to include \$20,792.23 for fiscal services to be provided by the Department of Accounts (DOA) to the CHRB, a 7% increase in salary for the CHRB Administrator, an hourly increase for each of the scientific consultants, and funding for a replacement for the current CHRB Administrator. Dr. Farrell seconded the motion and it passed unanimously. A breakdown of the DOA fiscal fee is provided in Attachment A. The contents of Attachment A are incorporated here by reference thereto as if they are fully set forth here.

Vice Chair Eric Lowe, M.D. moved that the Board approve a \$10,000.00 retainer fee to the OAG for legal services and approval of the MOU between the CHRB and the OAG as written. Dr. Farrell seconded the motion and it passed unanimously.



Next Meeting:

Chair Robert Downs, Jr., M.D., moved that the meeting be adjourned. The motion was seconded by Dr. Farrell, voted upon, and passed unanimously by the Board. The meeting adjourned at 5:20 p.m.

The meeting will begin promptly at 10:00 a.m. At this meeting, the Board will review the Concept Papers submitted, as part of the 2024/2025 grant process, and review the panel's recommendations regarding which ones should be developed into Full Proposals. The Board then will determine which Principal Investigators will be asked to submit Full Proposals.
